State Changes - Pennsylvania and New Mexico

Our member state associations continue to move forward in promoting coach education. Beginning in 2016, Pennsylvania will require coach education. New Mexico is upgrading its coaching requirements to include First Aid, Health and Safety for that state's Level 1 certification, pending late spring formal adoption of a change to the coaching licensure regulation. Upon adoption, this course will be required for all new Level 1 coaching license applicants effective July 1, 2014.

Congratulations to Dan Schuster

As of August 1, Dan will become the Director of Coach Education at the NFHS, succeeding Tim Flannery, who will retire July 31. Dan came to the NFHS in 2008 and has assisted in many of the administrative functions of the program. This includes playing an instrumental role in the development of the new Learning Management System (LMS) that will be implemented this year. Dan earned both his bachelor's and master's degrees from Indiana University. He is also a Certified Athletic Administrator (CAA) and Accredited Interscholastic Coach (AIC). In addition to his coach education responsibilities, Dan will assume supervisory duties for the NFHS Coaches Association and retain his position as national rules liaison for the sport of Ice Hockey.
