Hall Of Fame Inducts 12 Who Are Making A Difference

Congratulations to the Alabama High School Sports Hall of Fame's Class of 2011. The 21st class inducted last month is an outstanding group of 12 major contributors to high school sports in Alabama.

A total of 261 coaches, officials, administrators and other contributors have been inducted into the Hall since its inception in 1991. These men and women have all made a positive difference in the world as we know it.

The class includes football and basketball official Tony Baggiano, former football coach and major contributor Doug Barfield, basketball coaches Joe Belyeu, George Hatchett, Johnny Patrick, Jerry Weems and the AHSAA's own Wanda Gilliland, football coaches Lester Smith, Waldon Tucker and Lyle Underwood, baseball coach Bill Murrell and track coach Jim Tate.

The influence of this class, like those before them, will be long lasting.

Consider Jim Tate of St. Paul's, for instance. Coach Tate, a U.S. Army (Airborne) pilot who received the Air Medal and Bronze Star with Oak Leaf Cluster for his service to our nation in the Vietnam War, has guided his St. Paul's teams to 90 state championships in boys and girls cross country, indoor track and field and outdoor track and field. He was selected the National High School Coaches Association Track Coach of the

Year. His girls' cross country team still holds the national record for consecutive state championships with 16 from 1983-1998.

More importantly, he has mentored hundreds of young people in the lessons of life. When he started the track program at St. Paul's in 1978, the school didn't even have a track. Now the school has a track field house that bears his name.

St. Paul's school headmaster F. Martin Lester, Jr., said this of his track coach. "The real story of Jim Tate is that of a gentle leader, who, in turn, makes leaders of young men and women. He does so not through a harsh win-at-all-costs approach, but through positive encouragement, a sense of humor, a sense of duty and humbling personification of the Golden Rule." This kind of im-

pact is representative of all our inductees past and present.

I want to personally thank them all for what they have meant to those placed in their trust. I also want to thank the many who came to Montgomery for the Hall of Fame banquet to honor these outstanding individuals and to make their day such a special memory and the many former inductees who attended the event once again.

A lot of work and preparation goes into the event each year. AHSADCA Director Steve Bailey oversees the nomination and selection process through the selection committee. For the entire AHSAA staff, this is a labor of love. Alan Mitchell, Charlotte Davies and Sandy Logan have been key leaders in this special banquet each year. Alan and Charlotte also have spent countless hours developing the Hall of Fame housed at the AHSAA office. Sandy and her daughters worked all day Sunday preparing the food for the Open House/Reception.

Outside Participation, College Tryouts Have Restrictions

The AHSAA receives a number of inquiries most weeks concerning two very important items that could have a profound effect on a student-athlete's eligibility: outside participation and college tryouts.

The AHSAA rules governing these times can be found in the AHSAA 2010-11 Handbook on pages 23-24. Coaches need to understand the limitations clearly so they can advise the student-athletes and parents of the AHSAA rules and regulations governing these matters.

RULE 1: ELIGIBILITY
SECTION 6. OUTSIDE PARTICIPATION RULE. A student
who is a member of any school
athletic team (grades 7-12) may not
participate (includes practice) on a
non-school team in the same sport
during the school season of that
sport. A student who is a member
of any high school athletic team
may not participate in an outside
sport activity in the same sport
during the school season of that
sport.

Note: Olympic Development programs are exempted from the Outside Participation Rule. One evaluation per month has been approved by the AHSAA.

Note: Private individual instruction is not considered an outside sports activity.

A student who violates this rule becomes ineligible to compete on that school team or in that school sports activity for the remainder of that school season. Any student who participates on an outside



team after the school sport season begins is ineligible to join that school team for the remainder of that season. A team's season begins the day of that team's first contest and ends when that team's season has been completed. An ineligible student cannot participate with an outside team after the school team's season starts and then join the school team upon becoming eligible. (A) INDEPENDENT RULE: A student who is a member of any school track and field, cross country or wrestling team may participate as an independent in two outside activities during the season of a sport with the permission of the school principal. The schedule of the school team, including its championship play, takes precedent over any outside participation of an individual. (Members of tennis, golf and swimming teams are not limited to the number of outside events.)

Note: An outside event is one that is not sanctioned by the AHSAA.

(B) FIFTY PERCENT RULE: Participation (includes practice) during the school year on a non-school team outside the school season by students that will play the following season on the same high school varsity or junior varsity/B-team (grades 7-12) is limited to 50 percent of the number of players required to play the game (i.e., three in basketball, six in soccer, five in baseball, etc.).

Note: In each sport, only the specified number of students participating on a non-school team during the school year may be placed on the same high school team roster the following season. Those students cannot be interchanged on the school team roster. A freshman team at a high school is considered a junior high team just like a 9th grade team at a junior high school. This rule does not apply to seniors who have completed their high school eligibility in that sport or to middle and junior high school students who will not play on a high school team the following season. This rule applies to students attending individual camps during the summer.

SECTION 7. HIGHER LEVEL PAR-TICIPATION. A high school student who enrolls or registers in an institution of higher rank than high school or plays on an athletic team of such an institution shall not be eligible to represent any high school in the state in athletics until reinstated by the Central Board of Control.

With the approval of a student's principal, enrollment in special classes for an accelerated or enrichment program is not a violation of the rules. However, a student who enrolls at another school in order to take special courses is not eligible at the new high school until the student has been enrolled for one full year.

Note: College tryouts are only permitted outside the high school sport season.

he fourth annual Principals and Athletic Directors Conference April 5-6 at the Renaissance Montgomery Convention Center will be a little different from previous conferences hosted by the AHSADCA and the AHSAA. This year's conference will be more discussion and less lecture. The guest speakers are outstanding – from the inspirational presentation of John Croyle to the down-to-earth insights of several outstanding attorneys concerning bullying, sexting, texting and the law. This special panel discussion scheduled for the 1 to 2:15 p.m. time slot after lunch on Wednesday, April 6, will include a special testimony from Mr. and Mrs. Mike Ellis, parents who have experienced the results of the type of behavior having such a profound effect on the students in our schools and across the nation.

Renowned education lawyer Donald Sweeney, an attorney from Birmingham who specializes in representing school systems, will also be on hand along with Montgomery attorneys James Robert Seale, Elizabeth Carter and Jayne Williams to discuss these important topics.

Among the other key topics to be discussed in the afternoon session are: Athletic Issues Facing the 21st Century Principal and/or Athletic Director, Emerging Sports Trends, Moral/Ethical Issues for coaching staffs and NCAA/NAIA Clearinghouse and Recruiting Rules.

The morning session will include Mr. Croyle's presentation as well as actual eligibility case studies that have been handled by the AHSAA staff involving member schools. A special panel of school athletic directors will discuss how to develop a school or school system Athlete/Coach Handbook. Leading this panel are St. Paul's athletic director Gerry Strang and Mountain Brook athletic director Terry Cooper, who is also a member of the AHSAA

Central Board of Control.

This year's conference kicks off Tuesday night (April 5) with special Leadership Training Course 619 taught by Saint James School AD Jerry Browning. The course is scheduled from 3 to 7 p.m. at the Renaissance Center.

The CAA Exam will also be administered from 6 to 8 p.m., and special reception for attendees will be hosted by the AH-SAA staff from 6:30 to 7:30 p.m. To register for the CAA Exam, go to www.niaaa.org for requirements, certification process and application.

Deadline for pre-registration was Friday, April 1. However, attendees can still register on site. The registration fee includes a conference gift.

2011 Bryant-Jordan Banquet To Be April 11

with no ejections.

We also want to remind coaches to check their on-line rosters to make sure that all names are correct with uniform numbers (if applicable), school year, position and heights (if applicable). As the regular season concludes, make sure to create the post-season (tournament) rosters as required by the deadline dates listed in the AHSAA Spring Sports Book for each sport.

It is also very important that all scores are reported during the regular season and that playoff scores be reported immediately following contests each night.

SOFTBALL: Area softball tournament directors must fax or email area tournament brackets to the AHSAA by Monday, April 25, 10 a.m. Area tournaments can be played any time beginning April 29 through May 7.

BASEBALL: All area baseball contests should be completed prior to April 18 with area champions and runners-up determined by then. Area winner and runner-up teams must fax or email their first-round game times and sites to the AHSAA office no later than April 18 (10 a.m.).

The first round of the state playoffs will be played April 22-23. Once the playoffs begin, the winning coaches in each round should fax or email game times and sites for the next round to the AHSAA office by the following Monday, 10 a.m.

SOCCER: In Class 6A, all section soccer matches must be concluded prior to April 25 with the top four-ranked finishers reported to the AHSAA by fax or email by 10 a.m. on that date. In Classes 1A-4A and Class 5A, section matches must be played prior to April 28 with the winner and runner-up in each section reported to the AHSAA by 10 a.m. on that date.

The first round of the state playoffs for Class 6A is April 30. The first round for all other classifications is May 3.

AHSAA Baseball Pitching Rule Has Been Modified

With baseball in full swing already this spring, it is important to remind our coaches that the AHSAA baseball pitching limitation rule has been modified slightly for the purpose of better protecting a pitcher's arm. It was recommended by the AHSAA Baseball Coaches Committee and the AHSAA Sports Medi-

cine Advisory Committee to increase the number of days rest between pitching occurrences.

The number of days rest was increased from two days to three days between pitching occurrences when a pitcher pitches 7 innings over a single day

or two-consecutive day period. A player may make two pitching appearances in one day or over two consecutive calendar days, after which three consecutive calendar days of rest are required before being eligible to pitch again. A player's eligibility to pitch is not determined by the number of hours between pitching appearances.

It is important to note that an appearance is an official participation as a pitcher. (An appearance is concluded upon the player's removal from the pitcher's position or by the conclusion of the game.)

This is the first major change we have had to the pitching limitation rule since it's inception. We feel this is a very productive change and look forward to having fewer issues with pitching arm injuries in our state.

AHSAA Officials Camp Schedule Is Set

The 2011 AHSAA State Officials Training Camps are set. These camps are used as training sessions for officials from across the state. The camps aid in establishing consistency in the way officials work games statewide. During the camps we have them actually working games and demonstrations. 


