



2013 Swimming & Diving State Meet

This meet will be conducted under the auspices of the Alabama High School Athletic Association and the 2013-2014 NFHS Swimming and Diving Rules Book and as an Observed meet under Southeastern Swimming, Inc., of United States Swimming .

ELIGIBILITY: All participants must be eligible under AHSAA rules. Only high school varsity teams and individuals representing high schools are eligible for the state meet. All participants in any meet must be accompanied by a faculty member from their school.

FACILITY: POOL - Indoor 50 meter by 25-yard pool, offering 16 lanes for short course competition. Only 8 lanes will be used for competition, unless size of meet requires us to use 2 courses for preliminaries. It is one of the fastest pools in the country with pool depth ranging from 9 feet to 16 feet.

TIMING: Automatic timing will be provided by Colorado Timing System with HYTEK interface on both courses. Manual back up will be used. An 8-lane scoreboard will be available.

MEET FORMAT: All events will be conducted in short course yards. This will be a combined Swimming and Diving Competition, with the diving being conducted separately from the swimming within this facility. The diving competition will be conducted in its entirety on Friday, December 6. The swimming will be conducted in a Prelim and Finals format, with the Prelims being conducted on Friday, December 6 and the Finals portion the following afternoon. There will be a 15 minute break between the 50 yard Freestyle and the 100 yard Butterfly events. Swimmers will be allowed to swim down and warm-up during the 15 minute break.

STARTING TIMES:

Please note: The boys will dive first followed by the girls.

Swimming Prelims: 3:30 p.m. - Warmup

5:00 p.m. - Competition

Please note: Boys' heats will be swum first followed by the girls in each event.

Swimming Finals: 1:00 p.m. - Warmup

2:00 p.m. – Competition

200 yd. medley relay
200 yd. freestyle

400 yd. freestyle relay

Special Rules:

1. Participants must equal or exceed the established qualifying times for all individual swimming events in order to be eligible for the State Meet. There are no qualifying standards for relays or diving.
2. Qualifying times may be achieved any time after August 1, 2013 in sanctioned high school meets, USA-sanctioned meets, Parks and Recreation-sponsored meets and any other approved meet. (A seasonal membership fee may be involved with participation in the USA Swimming meets.)
3. If a swimmer fails to achieve qualifying time in any State Meet event, the coach must provide Proof of Performance for the entered time (a copy of meet results). Otherwise, the swimmer will be disqualified from the State Meet. A Proof of Performance clerk will be available at the head table.

ENTRIES: Swimming Entries must be received by the meet director by Monday, December 2 at 5 p.m. Late entries will not be accepted. Entries must be submitted using H Y-Tek software or equivalent. Names of all potential relay swimmers must be included in the entry file. A .pdf file of your entry should be included as well as contact information for the person responsible for the entry, in case of questions or errors. Changes cannot be made to entries after the deadline, except for errors on the part of the meet director. Please double check your entries before submitting them.

This meet has been submitted for approval of Observation of USA Swimming technical rules. For those USA-S swimmers entered into the meet database with accurate USA-S ID numbers, all times from legal USA-S swims will be automatically loaded into the national times database. PLEASE do NOT “create” ID’s in Team Manager for non-USA-S athletes. **The USA-S athlete’s correct USA Swimming ID#, registered full name with middle initial and date of birth must be included with the entry.**

Leadoff splits for individual events and relays must be specifically requested in writing. Requests must be made by submission of the SES Individual Verification Request Form by the athlete or coach within two weeks of the last day of the meet and submitted to the LSC Times Chair. Forms are available at: www.seswim.org/forms An LSC administrative fee of \$5.00 per swimmer must be submitted with the request, payable to Southeastern Swimming, Inc. If submitted past the deadline, \$10 per swimmer late fee applies.

Diving Entries should be entered using www.divemeets.com. Divers should also be included with the swimming entry. In accordance with NFHS rules, divers are allowed to change their list until 60 minutes prior to the start of competition. Dive lists must conform to NFHS rules for a championship meet.

NUMBER OF EVENTS: A team may enter only four individuals per event and one relay team per event. A participant may enter a maximum of four events (diving events included), no more than two of which may be individual events. Over entries will be deleted from the fifth entry on.

Note: Schools may enter their relay teams without individual names. It shall not count as an entry unless the competitor actually competes in the event. All students included in the entry may swim in the prelims, swim-offs and/or finals of relays provided he/she does not exceed the permitted entries for the meet. A relay alternate may be listed beside an entry's name, but any substitution must be made prior to the start of the meet.

An event may be deleted at any time; however events may not be added after the entry deadline.

ENTRY FEES: No State Meet Entry Fees: New Central Board policy eliminates entry fees for the state meet since an admission is required.

CHECK-IN: Coaches may register and pick -up school team packets in the Office from 8:30 a.m. to 4 p.m. Friday. Only the coach or faculty advisor may register for a team.

SCORING: Will be to 16 places as follows:

AWARDS: (a) Trophies for winner and runner-up teams in each division

COACHES' MEETING: A coaches' meeting will be held 10 minutes prior to each session in the hospitality room. No swimmers will be allowed in the pool during this time.

AMMENITIES: Hospitality services will be provided for coaches and officials. A first aid station will be located on the pool deck and staffed with an AHSAA trainer. Concessions will be available.

PARKING: On Friday, before 5pm, fans and participants should park in the lot in front of Beard-Eaves Memorial Coliseum (corner of Coliseum Dr and Biggio Dr) or in the McWhorter Center lot (corner of Biggio and Samford). Most campus parking restrictions end at 5pm so cars may be parked in spaces zoned "A", "B", "C", or "PC" after 5pm on Friday. Parking permit regulations will be enforced on Friday around campus in all lots other than the Coliseum Lot and the McWhorter Center lot due to class being in session. Any vehicle parked in spaces other than at the Coliseum or McWhorter Center is subject to ticket and/or towing if not displaying proper permit. On Saturday, permit regulations are not in effect so cars may park in any legal parking spot on campus.

PRACTICE: The Aquatics Center will be open for practice for both swimmers and divers on Thursday, December 5 from 6pm-9pm and from 8am-10am on Friday, December 6. The diving boards will close to female divers at 9:00am. They will be given an additional 1 hour warm-up following the completion of the of the boys' competition. There are no assigned lanes or groups for warm-ups.
