2014 Super Sectional Wrestling Information

Tournament packets will be provided to you at the Team Pass Gate Entrance for each site. (North and South) In your packet will be a copy of the brackets, participant's credentials for admission and participant rosters. You will need to bring with you a copy of your C2C Wrestling varsity team roster which includes all of your eligible varsity team members. This roster will be used for admission purposes at the Team Pass Gate for non-participating team members. No roster means no free admission to non-participating team members!

I will run a final report next week to see who is in compliance with the weight management program. If this requirement is not fulfilled by Wednesday, (Feb 5), your athletes will not be eligible to be seeded and your school will be fined. If you still have questions on how to complete this requirement, you need to contact the NWCA at (717) 653-8009. They will help you.

Mr. Don Korn sent out the following information on a separate email which contains items you must complete to ensure fair and accurate seeding by Trackwrestling.

In preparation for the upcoming Super Sectionals, please check to make sure your team and coaches profile is updated in Trackwrestling (email and phone number). You will receive an email about registering your team for sectionals on Trackwrestling. If your profile (email) is wrong, you will not receive the link. You can also check your team's Super Sectional access through your team's Trackwrestling home page by clicking on the AHSAA Super Sectional link on your schedule. If you have not added the Super Sectional to your schedule, please do so and link it to your Super Sectional tournament and you will see your registration link. Make sure that your school's classification is included and accurate. Example: (6A), (5A), (4A-1A)

You will have until Wednesday, Feb 5, 2014 at 5 p.m. to import your roster. It is very important that your wrestlers' records are up to date prior to importing, as seeding will be automated based on the AHSAA criteria.

The system automatically reviews your head-to-head and common opponents based on your wrestlers' records in Trackwrestling. The NWCA site reconciles with Trackwrestling so they should be the same no matter which system you input your results. It is also important you import your roster on Trackwrestling as opposed to typing in your wrestler's name and record. This way it will link your wrestlers' profiles and matches for proper seeding.

There will be no seeding meeting because the seeding process will be automatically done based on the following criteria by the Trackwrestling system:

1. To be seeded, a wrestler must have participated in a minimum of nine (9) matches overall and have a .500 record or have reached seeding criteria A, B or C.

Seeding criteria:

- A. Head-to head
- B. Common opponent

C. Overall record (Highest winning percentage in matches against instate opponents from the same AHSAA wrestling classification (6A),(5A),(4A-1A)).

Item D will be used to determine the seed if two or more wrestlers are tied for the same seed. (Flip of

a coin) If this rare occurrence happens, AHSAA Staff and the two Coaches involved will do this via a Conference Call.

The deadline to enter your roster is Wednesday, Feb. 5th at 5 p.m. Seeding will be done automatically and completed by Thursday, Feb. 6th at 5 p.m. The brackets will be made available to everyone at that time.

<u>Weigh-ins:</u> These weigh ins for the Super Sections will be done Team by Team. The weigh in times will be strictly enforced. If you team does not weigh in during the designated times, your athletes will be disqualified. Teams will be weighed in on a first come, first serve basis.

ENTRY FEE: \$100 per team (5 or more athletes) or \$20 per individual (payable to the AHSAA) must be submitted at the team sign-in table at the participants' entry gate.
